TERMS AND CONDITIONS

- 1. Details of miscellaneous scrap available for disposal are enclosed in Price Bid format.
- 2. The successful bidders shall remove the scrap from KSINC premises at his own cost and responsibility, within 15 days from the date of sale order. Item no. 4 and 5 scope is to clearing the scrap at ground level. Retention of any material included in the lot is not allowed.
- 3. The Successful bidder shall remit the tendered amount in full as per his tender within 5 days from issue of sale order.
- 4. The tender document can be downloaded from the website www.ksinc.in and cost of the tender document Rs.2, 500/- (GST @ 12% extra) shall be remitted along with the tender by way of DD, drawn in favour of "KSINC LTD", payable at Ernakulam.
- 5. Tender complete in all aspect to be submitted to KSINC Head Office, Gandhi Nagar, on or before 19.11.2018, 03.00 PM. Received tenders will be opened on same day at 03.30 PM, in the presence of the tenderers present.
- 6. Along with the tender, the tenderer should remit the E.M.D of Rs. 2, 00,000/-, along with the tender by way of DD, drawn in favour of "KSINC LTD", payable at Ernakulam. Tenders without EMD will be summarily rejected. No exemption will be allowed from remitting EMD and cost of tender documents. No interest on the EMD will be paid.
- 7. EMD of the successful tender will be released only after disposal of complete scrap items from KSINC Slipway Complex, Thoppumpady. EMD of the other tenderes who participated in the tender will be released after one week from tender opening.
- 8. The said Earnest Money Deposit (EMD) will be forfeited if:

- A tenderer withdraws his bid before finalization of the tender or before expiry of the validity period of the tender.
- In the case of a successful bidder, in the event of breach of any of the Terms and Conditions of the Tenderer.
- In case if the successful bidder fails to remove the scrap as per the tender / sale order or fails to remit the scrap value within the time period indicated in the tender.
- 9. The tenderer should read the terms and conditions and sign in each page as token of their acceptance of the terms and conditions.
- 10. The rates quoted shall be inclusive of all taxes, levies, cess, octroi or any other local, state or central taxes as applicable or charges by local, state or Central Government.
- 11. The acceptance of a bid will rest with the company, who does not blind themselves to accept the highest tender and reserves the right to themselves the authority to reject any or all of the tenders received, without assigning any reason.
- 12. The tender should be open for acceptance for 30 days from the date fixed for its receipt. Should, any tenderer withdraw his tender before this date, the EMD deposited by the tenderer will be forfeited.
- 13. The tender should write legibly and free from erasure, and over-writings or conversions of figures. Corrections where unavoidable, should be duly attested with dates. The rates quoted shall be written in words as well as in figures.
- 14. The bidders may inspect the scrap lying at the KSINC Slipway Complex, Thoppumpady, during office hours. The tenderer shall be deemed to have full knowledge of the present condition of the scrap, whether he has inspected or not. The submission of tender implies that the tenderer has read this notice and conditions of sale and has made himself aware of the conditions of the scrap. The expenses of inspection i.e. travelling and any other charges shall be borne by the tenderer. The quantity of items mentioned in the price bid format may vary since those are only approximations.
- 15. If the tenderer fails to remit the tender value in 5 days from receipt of sale order, the Company at its discretion will cancel the sale order and EMD will be forfeited. The goods will thereafter be resold at the "risk and cost of the defaulting tenderer", who shall be responsible for the deficit if any and who shall not be entitled to any benefits in the

- event of any increase in the price arising out of such resale. KSINC reserves the right to take such further action against defaulting as they may be authorized by law.
- 16. After the issue of sale order to the successful tenderer, the scrap will lie in the KSINC premises at the risk and responsibility of the buyer. The buyer shall take adequate steps for safety and security of the equipment till the same is removed from the site. KSINC shall not be responsible for any loss or damage after issue of sale order.
- 17. Scrap shall be removed within 15 days from issue of sale order, failing which, penalty will be charged at the rate of Rs.1000/- per day for additional days.
- 18. The buyer shall take all measures to ensure safety of his employees. The Company is not liable to pay any compensation or responsibility for claims for losses, damages or accidents etc. If by force & of circumstance, if the company has to pay such claims, the amount will be deducted from any amount due to the buyer.
- 19. This contract shall be governed by the Indian Contract Act, 1872 and all payments due from the contractor under the contract shall be made in Indian Currency.
- 20. Revised or amended offers after the closing date of the tender will not be entertained under any circumstances.
- 21. Tenders which do not fulfill all of the above conditions or are incomplete in any respect are liable for summarily rejected.
- 22. Canvassing in connection with the tenders is strictly prohibited and tenders submitted by the tenderers who resort to canvassing will be liable to rejection.
- 23. The entire tender document including the tender notice, schedule, condition, etc., should be returned duly signed on each and every page, as a token of acceptance of the conditions.
