TENDER FOR SALE OF SALE OF WATER SPORTS EQUIPMENTS

I. General Conditions on submission of Tender:

1. The tenders shall be submitted in the prescribed form. Tender documents are available from the web site www.ksinc.in of the company. The tender documents are available till **25-11-2017 3.00 pm**
2. Last date for submission of the tenders is **25-11-2017 3.00 pm** Tenders received after this time will not be accepted for any reason. Received tenders will be opened at 03.30 PM same day in the presence of tenderers, if any.
3. The bid shall be in a sealed cover and shall contain full address of the bidder. The EMD also shall be furnished along with the bid. The cover shall be superscribed with **“Tender for Sale of WATER SPORTS EQUIPMENTS”**.
4. **EMD:** An amount of Rs.32,000/- shall be remitted as EMD along with bid. The EMD may be remitted by way of a DD from any scheduled bank payable at Ernakulam drawn in favour of Kerala Shipping and Inland Navigation Corporation Ltd.
5. The successful bidder should remit the amount in full within 7 days and can take over the Equipments within 3 days of the payment.
6. The EMD of the two highest bidders (H1 and H2) will be kept and it will released only after the completion of tender procedure.
7. The bidder should notice that GST rules are applicable to this tender amount.
8. The Equipments can be inspected up to 25-11-2017 2:00 PM with prior appointment. Bidders may contact Marketing Manager on 9846223888, 0484-2203614 for clarifications and appointments.
9. The bidder should take over the equipments in *as is where is* condition. No extra cost will be borne by the company in this respect.
10. KSINC reserves the right to reject any or all quotation at the sole discretion without assigning any reasons whatsoever.
11. The tenderers can participate in the tender either to buy the equipments (mentioned in Annexure -1) individually or collectively.

12. In the event of the person to whom the sale order awarded, has failed to take over any one or all the equipments as per his choice, his EMD will be forfeited. EMD will be forfeited on the following grounds also:
 - a) A tenderer withdraws the bid before finalisation of the tender or before expiry of validity period of the tender.
 - b) In the case of successful bidders, in the event of breach of any of the terms and conditions of the tender
 - c) In case the successful bidders failed to take away the Equipments as per the tender or failed to remit the sale proceeds.
13. EMD of the unsuccessful bidders shall be refunded within 07 days of the opening of the tender.
14. A copy of the ID proof (with photograph) and PAN card should be attached along with the tender document.
15. The tenderer should read the terms and conditions and sign in each page, as token of their acceptance of the terms and conditions. Individual rates to be quoted for each item in the Price Bid schedule enclosed as Annexure –II and are mandatory.
16. The rates quoted shall be exclusive of all taxes, levies, cess, octroi or any other local, state or central taxes as applicable/charged by local, state or Central Government. Taxes may be shown separate.
17. The acceptance of a bid will rest with the company, who does not bind themselves to accept the highest tender and reserves to themselves the authority to reject any or all of the tenders received without assigning any reason.
18. The tender should be written legibly and free from erasure, and over-writings or conversions of figures. Corrections where unavoidable, should be duly attested with dates. The rates quoted should be written in words as well as in figures.
19. The bidders may inspect the WATER SPORTS EQUIPMENTS now kept at the KSINC Ferry Terminal at High Court Junction and Thevara Boat Yard during office hours, with prior appointment. The submission of tender implies that the tenderer has read this notice and conditions of sale and has made himself aware of the condition of the items, scope and specifications and other factors bearing on the tender. The expenses for inspecting the items i.e., travelling and any other charges shall be borne by the tenderer.

20. The successful tenderer shall deposit with KSINC the tendered amount in full within 5 days from the date of issue of sale order. After depositing the amount, a sale invoice will be issued to successful tenderer enabling him to take away the WATER SPORTS EQUIPMENTS.
21. If the tenderer fails to pay the purchase price as aforesaid or fails to collect the WATER SPORTS EQUIPMENTS within 10 days from the date of issue of sale order, the company may at its discretion cancel the sale order and EMD/SD/Sale Money deposited if any, paid shall be forfeited without prejudice to the rights to recover damages on account of such breaches. The equipments will thereafter be resold at the "risk and cost of defaulting tenderer", who shall be responsible for the deficit, if any, and not entitled to any benefits in the event of any increase in the price arising out of such resale. KSINC reserves the right to take such further action against defaulting as they may be authorised by law.
22. After the issue of the sale order to the successful tenderer the equipments will lie in the KSINC premises at the risk and responsibility of the buyer. The buyer shall take adequate steps for safety and security of the equipments till the same is removed within 10 days from the above site. KSINC shall not be responsible for any loss or damage to the equipments after the issue of sale order.
23. The revised/amended offers after the closing date of the tender will not be entertained under any circumstances.
24. Tenders that do not fulfil all or any of the above conditions or are incomplete in any respect are liable to be summarily rejected.
25. Canvassing in connection with the tenders is strictly prohibited and tenders submitted by the contractors who resort to liable to rejection.
26. All the tender documents including tender notice, schedules, conditions, etc. should be returned duly signed in each and every page, as a token of acceptance of the conditions.
27. This tender is issued subject to the jurisdiction of the honourable local courts of Cochin and no courts other than the local courts of Cochin shall have jurisdiction regarding any matters concerning this tender.
