2. The bidder shall not be blacklisted by the Government, any government agency or quasi-government undertakings.
3. The bidders are required to get a print out of this document, sign, scan and upload the signed copy as token of acceptance of the terms and conditions of the tender. No attachment shall be added to this document.
4. In case of any doubt, please contact the purchase section in the head office of the company.

GENERAL CONDITIONS OF THE TENDER:

- 1) **This tender will be an e-tender under single bid system: Price Bid only**
- 2) The tenders shall be submitted electronically at the website <https://www.etenders.kerala.gov.in> . To participate in the tender, the interested bidder shall have valid registration with the website. If the interested bidders did not have valid registration with the site, he / she is advised to register at the site at the earliest without waiting for the last date. Bids in any form, received in the office of the company will not be accepted.
- 3) Tender documents are available at the same website.
- 4) **EMD and tender form cost:** The bidders are required to remit the tender form cost (Rs.1,000 / + GST) and the EMD (Rs. 12,200/-) electronically at the e-tender web site. The tender form cost is not refundable. EMD of the unsuccessful bidders will be returned after completing the bid process.

- a. There is no need to submit physical copies of the technical documents to the office of the company. If the company requires for such physical copies, it will be called for and only then it will be required to be submitted.
- b. Notwithstanding anything so submitted, the company reserves its right to call for more details during the evaluation of the bid documents.

5) Price Bid:

- a. The rates quoted shall be inclusive of all taxes, duties and levies, freight. The rate quoted will remain unchanged irrespective of any change in taxes in future.
- b. A bill of quantity (BOQ) is specifically prepared for this tender. The bidders shall download the BOQ and submit their bids in that form only. The bidders are required to fill their name and address and the rate they intent to quote in the form.
- c. The bidders will require the latest version of Microsoft office Excel spreadsheet programme to complete the form / BOQ. The supplied BOQ shall not be modified in any case; otherwise, the system will not accept it for evaluation.
- d. The price bid format given in this tender document is for information purpose only.

6) Bids submitted directly to the office of the company in physical form will not be accepted under any circumstances.

7) Last date for submission of the tenders is **19.02.2022, 03.00 PM**. Tenders received after this time will not be accepted by the e-tender site.

8) The received bids will be **opened at 03.00 PM on 21.02.2022** and the financial evaluations and results of each evaluation will be published electronically.

9) In case of any dispute on the Tender / Purchase orders / Terms of the contract shall be subject to the arbitration of the Managing Director of the KSINC, and his findings shall be binding on both the parties.

10) The jurisdiction for all disputes arising out of this tender, subsequent purchase order / work order, agreement or any other matter related thereto shall be the Courts in Ernakulum, irrespective of the location of the bidders.

Section III – ELIGIBILITY CRITERIA AND EVALUATION OF BIDS:

The bids will be evaluated for pre-qualification criteria first and the financial bids will be evaluated in the second stage. In the case of single bid system verify the technical specification of each bid based on our requirement. B. Financial Evaluation:

The winning bidder will be the bidder who quoted lowest rate and the spares / accessories suitable for our requirement. In case of a tie, KSINC will decide the winner after considering the quoted brand, Certification details, Shelf Life of each item quoted by the supplier.
