 - 3) Details proving the eligibility and previous experience. (copy of work order and satisfactory work completion certificates from previous clients to be attached).
 - 4) Details of major works executed in last three years (Attach work completion certificate)
 - 5) Personal and experience details of Supervisors/Technicians/skilled workers, as the case may be, supposed to carry out the work.
