2. The successful bidders shall remove the scrap from KSINC premises at his own cost and responsibility, within 15 days from the date of sale order.
3. The Successful bidder shall remit the tendered amount in full as per his tender within 5 days from issue of sale order.
4. The tender document can be downloaded from the website www.ksinc.in and cost of the tender document **Rs.2500/- (GST @ 18% extra)** shall be remitted along with the tender by way of DD, drawn in favour of “KSINC LTD”, payable at Ernakulam / can be collected by remitting cash at KSINC HO.
5. Tender complete in all aspect to be submitted to KSINC Head Office, Gandhi Nagar, on or before 15.03.2022 at **03.00 PM**. Received tenders will be opened on same day at 03.30 PM, in the presence of the tenderers present.
6. Along with the tender, the tenderer should remit the **E.M.D of Rs.50,000/-** along with the tender by way of DD, drawn in favour of “KSINC LTD”, payable at Ernakulam. Tenders without EMD will be summarily rejected. No exemption will be allowed from remitting EMD and cost of tender documents. No interest on the EMD will be paid.

9. The tenderer should read the terms and conditions and sign in each page as token of their acceptance of the terms and conditions.
10. **The rates quoted shall be exclusive of tax.**
11. For MS Scrap GST considered is @ 18% rate.
12. The acceptance of a bid will rest with the company, who does not blind themselves to accept the highest tender and reserves the right to themselves the authority to reject any or all of the tenders received, without assigning any reason.
13. The tender should be open for acceptance for 30 days from the date fixed for its receipt. Should, any tenderer withdraw his tender before this date, the EMD deposited by the tenderer will be forfeited.
14. The tender should write legibly and free from erasure, and over-writings or conversions of figures. Corrections where unavoidable, should be duly attested with dates. The rates quoted shall be written in words as well as in figures.
15. The bidders may inspect the scrap lying at the KSINC SWC, Thoppumpady, KBY Thevara, KFT & Head Office during office hours. The tenderer shall be deemed to have full knowledge of the present condition of the scrap, whether he has inspected or not. The submission of tender implies that the tenderer has read this notice and conditions of sale and has made him aware of the conditions of the scrap. The expenses of inspection i.e. travelling and any other charges shall be borne by the tenderer. The quantity of items mentioned in the price bid format may vary since those are only approximations.
16. If the tenderer fails to remit the tender value in 5 days from receipt of sale order, the Company at its discretion will cancel the sale order and EMD will be forfeited. The goods will thereafter be resold at the “risk and cost of the defaulting tenderer”, who shall be responsible for the deficit if any and who shall not be entitled to any benefits in the event of any increase in the price arising out of such resale. KSINC reserves the right to take such further action against defaulting as they may be authorized by law.
